 - Overall movement toward the Topical is going well.
 - Weakness the number of co-sponsors which have signed on to support the conference.
 - Exhibitors and Booths have a limited number of participants signed up.
 - Gail Hawk (Local Chapter) Wants a competition but organization is not going well at this point.
 - May abandon competition and focus on workshop.
